- 1) If parents cannot present the "RC" / "AP" to the KG their child has been admitted to during the "centralised registration dates", the KG concerned may not be able to complete registration for their child. Hence, parents are required to submit "RC" application to EDB within the designated period.
- 2) If an applicant is admitted after the "centralised registration dates", he/she is still required to submit the "RC" / "AP" for registration. If an applicant wishes to change school after registering with a KG, he/she is required to get back the "RC" / "AP" from the KG with which he/she has registered. Upon getting back the "RC" / "AP" from a KG, the KG concerned will no longer reserve the place for the applicant. The registration fee paid to the KG with which the applicant has registered will not be refunded.
